

ORDINANCE SUMMARY

Notice is hereby given that the Borough of Waynesboro, Franklin County, Pennsylvania, will consider a proposed ordinance to adopt, which said ordinance proposes amendments to various Sections of Chapter 280 of the Code of the Borough of Waynesboro, prescribing traffic and parking regulations in the Borough of Waynesboro, at the regularly scheduled public meeting of the Council of the Borough of Waynesboro on WEDNESDAY, JUNE 20, 2018, at 7:30 p.m., in the second floor Council Chambers of Borough Hall, 55 E. Main Street, Waynesboro, Pennsylvania.

A summary of the proposed ordinance follows:

AN ORDINANCE OF THE BOROUGH OF WAYNESBORO, FRANKLIN COUNTY, PENNSYLVANIA AMENDING VARIOUS SECTIONS OF CHAPTER 280 OF THE CODE OF THE BOROUGH OF WAYNESBORO ENTITLED "VEHICLES AND TRAFFIC"

SECTION 1: Amends Chapter 280 of the Code by adding an additional intersection to Section 280-12, entitled "Stop Intersections Established."

SECTION 2: Amends Chapter 280 of the Code by adding eight additional street locations to Section 280-20, entitled "Parking Prohibited in Certain Locations."

SECTION 3: Amends Chapter 280 of the Code by removing a location from Section 280-20, entitled "Parking Prohibited in Certain Locations."

SECTION 4: Amends Chapter 280 of the Code by adding an additional location to Section 280-21, entitled "Parking Prohibited in Certain Locations Certain Days and Hours."

SECTION 5: Amends Chapter 280 of the Code by adding six parking spaces to Section 280-25, entitled "Special Use Zones Established; Parking Otherwise Prohibited."

SECTION 6: Amends Chapter 280 of the Code by removing three parking spaces from Section 280-25, entitled "Special Use Zones Established; Parking Otherwise Prohibited."

SECTION 7: Amends Chapter 280 of the Code by removing one parking space from Section 280-30, entitled "Parking Meter Zones Established; Days and Hours Parking Meters Apply."

SECTION 8: REPEALER. All provision of previous Ordinances which are contrary to this Ordinance are expressly repealed.

SECTION 9: SEVERABILITY. The provisions of this Ordinance are severable and if any of its sections, clauses, or sentences are held illegal, invalid, or unconstitutional, such provisions shall not affect or impair any of the remaining sections, clauses or sentences.

SECTION 10: SAVINGS CLAUSE. In all other respects, the Code of the Borough of Waynesboro shall remain as previously enacted and ordained.

SECTION 11: EFFECTIVE DATE. This Ordinance shall become effective upon adoption.
