

**ORDINANCE NO. \_\_\_\_\_**

**AN ORDINANCE OF THE BOROUGH OF WAYNESBORO,  
FRANKLIN COUNTY, PENNSYLVANIA, AMENDING VARIOUS SECTIONS  
OF CHAPTER 280 OF THE CODE OF THE BOROUGH OF WAYNESBORO  
ENTITLED “VEHICLES AND TRAFFIC”**

WHEREAS, the Borough Council of the Borough of Waynesboro, Franklin County, Pennsylvania, deems it to be in the best interest and the general welfare of the citizens and residents of the Borough to amend certain sections of Chapter 280 of the Code of the Borough of Waynesboro entitled, “Vehicles and Traffic”.

NOW THEREFORE BE IT ENACTED AND ORDAINED by the Mayor and Borough Council of the Borough of Waynesboro, Franklin County, Pennsylvania, and it is enacted and ordained as follows:

**SECTION 1:** Chapter 280 of the Code of the Borough of Waynesboro, Article II, §280-12 entitled, “Stop intersections established” Subsection A, is hereby amended to add the following:

| <b>Stop street</b>  | <b>Through street</b>   | <b>Direction of travel</b> |
|---|---|----------------------------|
| First alley south of King St. between N. Potomac St. & Garfield St. | First alley west of North Potomac St. between King St. & W. North St. | Westbound Only             |

**SECTION 2:** Chapter 280 of the Code of the Borough of Waynesboro, Article III, §280-20, entitled, “Parking prohibited in certain locations” is hereby amended to add the following:

| <b>Street</b>    | <b>Side</b> | <b>Between/Location</b>   |
|------------------|-------------|---|
| S. Church Street | East        | “No Parking Here to Driveway” beginning 109’ from the north curb line of Gay Street and extending 57.5’ to the north along the east side S. Church Street.                      |
| S. Church Street | East        | “No Parking Between Signs” beginning 14’ north of the north curb line of Gay Street and extending 47.5’ to the north along the east side S. Church Street.                      |
| W. Fifth Street  | South       | “No Parking Between Signs” Beginning 118’ east of the east curb line of Hamilton Avenue and extending 48’ to the east along the south side of W. Fifth Street.                  |
| N Grant Street   | East        | “No Parking Here to Corner” beginning at the northern curb line on the northeast corner of Alley No. 1 North and extending 20’ to the north along the east side N. Grant Street |
| N. Grant Street  | East        | “No Parking Here to Corner” beginning at the southern curb line of Alley No. 1 North and extending 20’ to the south along the east side of N. Grant Street                      |

| <b>Street</b>   | <b>Side</b> | <b>Between/Location</b>   |
|-----------------|-------------|---|
| King Street:    | North       | “No Parking Anytime” beginning 28’ west of the west curb line of Crown Court and extending 151.5’ to the west along the north side of King Street.  |
| E. Third Street | North       | “No Parking Between Signs” beginning 146’ east of the east curb line of S. Church Street and extending 66’ to the east along the north side of E. Third Street for the parking lot entrance to the Waynesboro Brethren Church.  |
| E. Third Street | South       | “No Parking Anytime” beginning 60’ east of the east curb line of the private alley west of Clayton Avenue and extending 52’ to the east along the south side of E. Third Street for the parking lot entrance to the Waynesboro Area School District Administration Offices. |

**SECTION 3:** Chapter 280 of the Code of the Borough of Waynesboro, Article III, §280-20, entitled, “Parking prohibited in certain locations” is hereby amended to remove the following:

| <b>Street</b>    | <b>Side</b> | <b>Between/Location</b>  |
|------------------|-------------|--|
| S. Church Street | East        | “No Parking Here to Corner” beginning at the northeast corner of Gay Street and S. Church Street and extending 57’ to the north along the east side of S. Church Street. |

**SECTION 4:** Chapter 280 of the Code of the Borough of Waynesboro, Article III, §280-21, entitled, “Parking prohibited in certain locations certain days and hours” is hereby amended to add the following:

| <b>Street</b>  | <b>Side</b> | <b>Between</b>   | <b>Days</b> | <b>Hours</b>          |
|----------------|-------------|--|-------------|-----------------------|
| S Price Avenue | West        | Beginning at the existing “No Parking Here to Corner” sign and extending 50’ to the south along the west side of S. Price Avenue | School Days | 8:00 a.m. – 9:00 a.m. |

**SECTION 5:** Chapter 280 of the Code of the Borough of Waynesboro, Article III, §280-25, entitled, “Special use zones established; parking otherwise prohibited” is hereby amended to add the following:

| <b>Street location</b>   | <b>Authorized use</b>  | <b>Hours</b>      |
|--|------------------------|-------------------|
| #201 Eden Avenue   | Handicap Parking Space | 24 Hours Everyday |
| Northwest quadrant in Center Square between #1 & #5 W. Main Street | Handicap Parking Space | 24 Hours Everyday |
| Southeast quadrant in Center Square between #2 & #8 E. Main Street | Handicap Parking Space | 24 Hours Everyday |
| #244 Ringgold Street   | Handicap Parking Space | 24 Hours Everyday |

| #121 W. Third Street | Handicap Parking Space | 24 Hours Everyday |
| #234 Wayne Avenue    | Handicap Parking Space | 24 Hours Everyday |

**SECTION 6:** Chapter 280 of the Code of the Borough of Waynesboro, Article III, §280-25, entitled, “Special use zones established; parking otherwise prohibited” is hereby amended to remove the following:

| <b>Street location</b> | <b>Authorized use</b>  | <b>Hours</b>      |
|------------------------|------------------------|-------------------|
| #221 Dickinson Avenue  | Handicap Parking Space | 24 Hours Everyday |
| #231 W. Second Street  | Handicap Parking Space | 24 Hours Everyday |
| #96 W. Sixth Street    | Handicap Parking Space | 24 Hours Everyday |

**SECTION 7:** Chapter 280 of the Code of the Borough of Waynesboro, Article III, §280-30 entitled, “Parking meter zones established: days and hours parking meters apply” is hereby amended to remove the following:

**S. Church Street:** The northern most metered parking space on the east side of South Church Street just south of Main Street.

**SECTION 8:** Repealer. All provisions of previous ordinances of the Borough of Waynesboro, which are contrary to this ordinance, are expressly repealed.

**SECTION 9:** Severability. The provisions of this Ordinance are severable and if any of its sections, clauses or sentences shall be held illegal, invalid or unconstitutional, such provision shall not affect or impair any remaining sections, clauses or sentences of the same.

**SECTION 10:** Savings Clause. In all other respects, the Code of the Borough of Waynesboro shall remain as previously enacted and ordained.

**SECTION 11:** Effective Date. This ordinance shall become effective upon adoption.
