 - (B) **Employer's Liability - \$100,000 each accident, \$500,000 policy and \$100,000 each employee**
2. **General Liability - including coverages for direct operations, operations sublet to other contractors, contractual liability and completed operations with limits not less than those stated below:**
 - **\$1,000,000 General Aggregate Limit (other than products and completed operations)**
 - **\$1,000,000 Products - Completed Operations Aggregate Limit**
